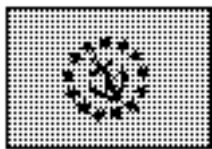

The General Membership Meeting will be held on Saturday, October 6, 1990 at Charlie Brown's Restaurant in the Banquet Room. (Charlie Brown's is located in Tacketts Mill Shopping Center - Upper Level - on Old Bridge Road.) This year we're moving away from the traditional norm of renting a Community Center and all the hassles that go along with it and we're going to spoil ourselves a bit. Instead of setting up/cleaning up, bringing a side dish, bringing our own beverages, the Club providing this and that, we're going to let Charlie Brown's do it all for us. The only catch is that we are going to have to assess a per person fee of \$6.00 to cover the cost of the food and a waiter or waitress to keep an eye on things. The bar will be set up with a bartender and Rail Drinks are \$3.00; Call are \$3.75; Beer is \$2.50 (Michelob is \$2.75); Wine \$3.25/glass.

It is anticipated that we will begin gathering about 6:30

p.m., with the meeting starting at 7:00 p.m. so we can conduct the necessary business before the live entertainment begins.

We will not be doing the 50/50 at this meeting; however, there will be burgees, jewelry, the few remaining cookbooks, and magnets available. And, of course, Mer and John will be there ready to take your membership renewals for the 1991 season; along with Quartermaster Walt Cheatham, taking orders for Club clothing.

Box 469, Occoquan, VA 22125 so your vote(s) can be counted. (A reminder - Associate Members will not receive the Ballot.)

Let's have another good turnout at another fun OYC function. See you at Charlie Brown's 10/6.

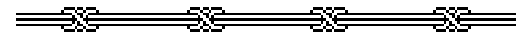

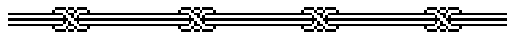
Candidates for 1991 Board

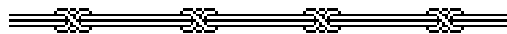


Quartermaster's Report

Galley Notes

Two of our readers have shared recipes that deserve our attention.

Mrs. Joyce Orr (better known as "Pokey") of Diamond Head, Mississippi, shares her summer picnic dinner at anchor. This combination of healthy, light fare seems just right for our hot dog-days of summer

Summer Picnic Dinner at Anchor Amaretto Punch Minted Fruit Marinated Shrimp & Vegetables

Amaretto Punch Serves eight

- 2 qts. chilled orange juice
- 1 qt. orange sherbert
- 2 cups Amaretto
- 1 qt. chilled orange soda

Float orange slices and drink.

Minted Fruit Serves eight

- 1/2 cup sugar
- 1/4 cup orange juice
- 1/4 cup lemon juice from concentrate
- 1/4 cup water
- 1/8 tsp. peppermint extract
- 4 cups assorted sliced fresh fruits

In medium bowl, combine all ingredients except fruit; stir until sugar dissolves. Place fruit in 1-1/2 quart shallow baking dish; pour on juice mixture. Cover; refrigerate three to four hours or overnight to blend flavors. Serve chilled.

Marinated Shrimp and Vegetables Serves eight

- 1 cup fresh cut cauliflower
- 1 cup cherry tomatoes, pierced with fork
- 4 oz. small whole mushrooms (1 cup)
- 1 cup sliced zucchini
- 1/2 lb. (1 cup) cooked shrimp, shelled and deveined
- 3/4 cup lemon juice from concentrate
- 3/4 cup vegetable oil
- 1 tbsp. salt
- 1/4 tsp. dried dill weed
- 5 drops hot pepper sauce

In 1-1/2 quart shallow baking dish, combine vegetables and shrimp. In small bowl, combine remaining ingredients; mix well. Pour lemon mixture over vegetables and shrimp. Cover; chill several hours or overnight, stirring occasionally. Served chilled.

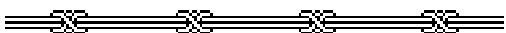
Si Williams, one of our local yacht surveyors, had just finished a survey for one of our buyers and as the end of the workday was upon us, he suggested that we repair to a local watering hole for some refreshments. As we were both marveled at the golden color and tiny bubbles of the Abita Beer, the conversation turned to food. Si knows his way around the galley, both on board and at home, so I was eager to hear his story about Shrimp Patty Jean.

One day Si was smiling around on the *Patty Jean*, his 57-foot lugger yacht at Grand Isle. The shrimp were running good that day and Si began rummaging around the galley cupboard for ingredients and ideas. He came up with butter, onion, green bell pepper, three turnips and the rest is history. I have tried this simple recipe and it is a winner. I refer to it as mystery shrimp because if done properly, your guests will never guess the ingredients.

Shrimp Patter Jean Serves four

1 cup turnips, peeled and diced
3/4 cup finely chopped onion
1/2 cup finely chopped green bell pepper
3/4 stick butter or margarine
salt and pepper to taste
1 to 1-1/2 pounds medium size deveined shrimp, cut in half

In a large saute pan combine all ingredients except bell pepper, cover and cook over medium heat for 10 minutes. Add bell pepper, cover and cook an additional eight minutes, or until shrimp are pink and just cooked through. Remove most of the remaining liquid, mash the soft turnip pieces, cover and cook for two more minutes. Serve and let your guests enjoy while they try to solve the mystery of the ingredients.



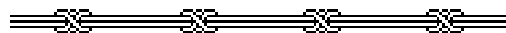
Cobb Island's Duck Man

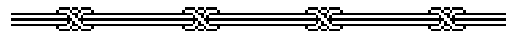


New Members John Piper

What do boatmen *really* want to know? According to the Technical Advisers at Overton's (a leading mail-order company), these are two of the most often-asked questions on their toll-free hot line (800-334-6541).

Q: *What anchor is right for my boat?*

A: It depends on where you're boating, maximum depth and the kind of bottom. For rock or coral bottoms, the advisers recommend a CQR anchor; for sand or mud, use a Danforth.

Q: *How far can a VHF transmit?*

A: The general rule is one mile per watt. Handhelds usually range from one to six watts; a stationary goes up to 25 watts for a 25-30 mile range. Of course there are other variables, such as height of antenna.

More Static on FCC Fee

BOAT/US Reports

Yet another twist to the Federal Communications Commission fee schedule has some boat owners seeing red over this latest government "user-fee."

A BOAT/US member who sent in her VHF ship station license application and a check for \$35 was stunned to find out that because she forgot to sign her application, it was returned and she will have to resubmit it with another \$35.

According to the FCC, the intent of Congress was quite specific in that the fees are intended to reimburse the government for time spent processing applications, even if the application was filled out incorrectly and must be returned.

In another development, some members are receiving rather misleading mailings from a private company that appear to be official letters from the FCC.

At least several BOAT/US members who recently applied for FCC radio licenses received official-looking letters from "Federal Licensing Inc." of Gettysburg, PA, that promise

"Important FCC License Info Enclosed." The letters contain photocopies of the members' own license applications with the FCC.

The letters are no more than a sales pitch hoping boat owners will shell out \$45 for a copy of the FCC regulations. (These same regulations are available from the Government Printing Office for \$20.) Contrary to what the letter implies, recreational boat owners are not required to have a copy of the FCC regulations.

According to the FCC, license applications are public information and anyone may have access to them. The U.S. Postal Service took action against Federal Licensing Inc. last year for mail fraud and misrepresentation for a similar sales pitch to another group of FCC licensees. An attorney for the Postal Service has told BOAT/US she will look into this latest sales pitch. Stay tuned.
