

A Handy Person's Story.... Continued No, I don't want any cheese to go with my WhINE and yes, Randy has already told me he will never ask me for my help again (a thought which I regret).

Last month my article was too long so the editor and I decided to make it a two-part article. Here's the second part of the story and thanks for reading the first part!

The back of our boat curves and has an angle to it. Therefore, you must put into the plan the curve, the angle, the cut out for the swim ladder, EVERYTHING was to be considered. This project was beginning to be something I wish I had paid someone else to do.

I would like some of that cheese to go with my WhINE! However, a better offer came and we took the afternoon off and went for a much needed boat ride with some friends. (Thank you, Rudy and Cookie.)

The next weekend we finished the project. By then Randy had done some more "thinking" about the project and had discovered ways we could improve the process. Of course, the biggest improvement I could have made would have been to remember the names of the equipment we were using. Hey, what do you want? I know the difference between a screwdriver and a wrench. I can tell what's long and what's short. I know what a clamp is and how it is supposed to work. (I may not know how to unclamp it though.) We made numerous trips to countless stores to get the much needed stainless steel screws, bolts, etc., used on such a project. (They are the ones that won't rust. Right?) Do I regret not going shopping? No, I truly don't. Although I may not like working on the boat the whole weekend I do enjoy working on projects with Randy. I can go shopping some other time.

Did I learn anything new? Yep, now I know how to work with acrylic, I know how to mark with a pencil and most importantly, I know how to almost get a breast reduction free of charge with the wrong slip of a saw!

On "Winning" the Bent Prop Award

If you were not at the OYC holiday party, you might find this interesting. If you were, I have an ending that is new.

As we walked forward to accept, I realized this was a special moment-not that I had a bent prop on a pedestal to display for a year, or that I would have my name engraved on the same plaque as my former next door neighbor in Lake Ridge (Geoge/Ginny Frank, '93), but that a message had been sent-and sent twice in two back-to-back awards. The board had really spoken about why this group really bands together as family. *–continued next page* All this was swirling around in my head as we accepted the award and were supposed to sit down so the evening could continue. But I stayed a moment by the mike and tried to express the thoughts just typed. And later when I had two helpings of that sticky cheesecake and my mind was really slowed down, it dawned on me I had left out another important point. It was Susan who did the MAYDAY on the radio and was in charge as everything was happening topside. She was in control. It was her situation; I was just an extension of the all important rag way down below. This award was from family to team. It was also subtly

Occoquan River Maritime Association Gaining Widespread Support

by Jim Ball, ORMA Coordinator Since I introduced the Occoquan River Maritime Association in last month's Daymarker, the new organization has received a lot of support from other organizations as well as individuals. As you recall, ORMA was formed to address the shoaling of the Occoquan Channel as well as coordinate the Occoquan Blessing of the Fleet, environmental and safety concerns as needed, and to investigate how we might restore the Port of Occoquan so that boaters could visit the town.

First, I should let you know that besides the written support of OYC's Board, we have also received letters of support from Salisbury Towing (on behalf of Virginia Concrete, Maryland Rock, the Arundal Corporation, and operators of the Captain Tom Tug), Belmont Town Center Associates (developers of the new housing and marina), Hoffmasters, Potomac Marine, Vulcan Materials Company (Operators of the quarry in Lorton), Fairfax Yacht Club, and West Marine Woodbridge. In addition, Prince William Yacht Club has assigned a member as a liaison to ORMA and OHM has promised to send a letter of support. We also hope to hear soon from the Occoquan Flotilla of the Coast Guard Auxiliary and the Northern Virginia Power Squadron.

All this support is needed to approach the Corps of Engineers to survey the problem, as well as ask our elected officials to take whatever appropriate action is necessary to get the channel dredged (it will likely need to be part of the Corps' Appropriation Bill for FY 2001). We will approach our elected officials and the Corps after the New Year.

I am also pleased to report that all three Yacht Clubs of the Occoquan have now identified their representatives to plan the Blessing of the Fleet, and we will have the first meeting to plan for it in January. We have new ideas, new initiatives, and are looking forward to a weekend of events this year if we can carry it off. Bonnie Breneman has volunteered as the primary representative from OYC.

On December 4th, five intrepid OYC'ers, under the ORMA flag, descended on honorary member Dick Lynn at OHM to discuss restoration of the Port of Occoquan. We went seeking advice and counsel and Dick was very helpful in explaining the issues, identifying appropriate contacts, and helping us in thinking about how to go about investigating this initiative. Walt Cheatham came up with a very innovative idea to build a floating dock along the waterfront as a transient dock that would not significantly affect any waterfront landowners who did not want to participate in the commenting on the first mate's need to be prepared and the captain's job to aid in that pursuit (not that I ever taught Susan anything in my life, but that's another story that detracts from the point.)

Glad I figured this out on my own that night at the table, because it became obvious three days later at home. The plaque on the front of the award is full of names—all singular, all captains. We were the first names on a new plaque on the back, and it says: "Walt AND Susan Cheatham, '99" [emphasis added].

Potomac Dredging Now Underway

As OYC motoryacht *Courchevel* arrived at the north dock of Alexandria's City Marina on December 17th, her nighttime arrival was well lighted by the U.S. Army Corps of Engineers' contract dredging company barges working nearby—and round the clock—on a long-planned but little publicized project to increase the river's depth to 24 feet along the Alexandria waterfront.

The dredge's huge clamshell bucket hauled up muck and mire and dumped each bite onto barges which would then be towed to the controversial dump site downstream in 35 to 50 feet of water in the main ship channel off Fort Belvoir, near Red Buoy 66. The dredgers will dump 321,000 cubic yards of yuck (not an engineering or environmentalist term) at this spot; and that prospect has been a cause for concern for those few people who have known about the plan since it was first aired in 1998. The rest of us were clueless until we saw a Washington Post article about the project on November 28.

The newly formed Occoquan River Maritime Association promptly started some dredging of its own, aided in large measure by Richard Krause and Dick Lynn. ORMA representatives and supporters (Jim Ball, Walt Cheatham, Steve Worcester, Ned Rhodes and m'self) contacted local government agencies, viewed the massive description of the project on the Engineers' website, lodged press queries with the Corps of Engineers on behalf of the Daymarker, contacted Congressman Tom Davis' office—all of which activity generated a storm e-mail and some useful information.

The concern about dumping in this location is that the spoil would destroy bottom dwelling sea life, spawning grounds, etc., and would generate a downstream run-off laden with pollutants. A further concern was the potential that backflow from tide could cause a worsening of an already very shallow access to Dogue Creek—where Mount Vernon Yacht Club, Mt.Vernon on the Potomac Marina, and the Ft. Belvoir Marina are located—and the already shallow Gunston Cove, where Pohick Bay Regional Park and boat ramp are located, and finally the back channel on the Virginia side of Craney Island, which would almost certainly catch loose spoil as it flowed downriver and could easily be shoaled.

Enough fuss was raised by ORMA, Potomac River area residents and Lorton community groups to lead to a public hearing on December 7th in Lorton. There the Corps of Engineers laid out the plans—elaborate, rational and generally but not totally convincing. Walt Cheatham and I attended the meeting, and we came away feeling that the Corps had done what appears to be an adequate job of investigation and documentation but a poor job of informing people in Virginia.

The Corps' documentation appears to insist that pollution levels are "within acceptable limits." Doubts remain, however, as they do on whether the Corps obtained all required approvals for the project. But suspicions alone don't stand up well against information stated as facts, and in the absence of proof to the contrary, we are pretty much stuck with the facts provided by the Corps.

As Walt Cheatham writes:

"After [the December 7th] meeting in Lorton, I'd say the worst thing we have here is less than perfect job alerting residents on the Virginia side of the river what was coming down. But in reviewing the material they had in a three-inch loose leaf binder, there was all sort of correspondence from groups who raised concern: environmental groups who no doubt follow such things closely and citizens groups that must have found out through other ways. I was surprised to find so much correspondence. I think it was more a case of the Post article reaching a larger audience than any cover up or attempt to steamroll."

The dredging in Alexandria and two other sites, Mattawoman Bar and Hunting Creek Bar, must be done by Feb 15 due to fish spawning. The Corps has declared that this dump site will be used only once, although there are other phases to this dredging down river and other projects on the books including the Wilson Bridge project.

Looking ahead and in the interest of avoiding further surprises, PRYCA Member at Large Walt Cheatham is now on the Corps of Engineers' mailing list for notification of future dredging projects. ORMA will also be keeping watch on dredging issues.
